How to submit claims - receive remittance advice – ask for help

So, you have arrived at inetclaims.com and are wondering what to do next

Firstly, you are in the right place if ...

- You are a registered user of this provider portal, or
- You are a provider of medical services to eligible members of Amerivantage health plans, and
- You participate in IntegraNet Health Services Networks - or not – and
- You wish to submit a claim for payment of services rendered as of August 1st, 2019, and
- You intend to submit your claim only in standard paper or electronic form.

Your First Visit?

If this is your first visit to the Provider Portal, welcome, and here is a list of things you can do:

- Learn where to send paper claims. You would drop to paper if:
 - You do not want to enroll as a Provider Portal user and submit claims electronically
 - Your claim requires attachments as a condition for approval
- Learn how to enroll on the Provider Portal and submit claims electronically, receive remittance advice notices electronically, and receive EFT payments.
- Learn how to contact IntegraNet Health Claims Department staff.
- Learn where to get additional services such as an Authorization.

What is in this Guide?

This document guides you through using the portal home and user pages.

On the Portal Home Page registered providers can login, and instructions are presented for registering as a new portal user, submitting paper claims, and contacting other services.

On the Portal User Page registered users can submit electronic claims online and download electronic remittance advice notices online for claims processed and paid/denied.

- Portal user enrollment instruction section
 - For each billing point, represented by one TIN, download the Enrollment Package and
 - Complete and sign the trading partner agreement
 - Complete and return the EDI registration form
 - Complete and mail the EFT agreement form
 - Approved users will receive accounts and passwords to login to the portal
 - If you bill claims for multiple providers with different TINs then call the IntegraNet Health Claims Department to review and receive detailed instructions

Provider Portal and EFT Registration:

- For access to the Provider Portal and to register for EFT, the [Enrollment Package](#) must be completed and returned.

- Paper claim submission instruction section
 - Defines the acceptable claim forms and specifies mailing instructions



- Both portal users and non-users can submit paper claims
- Submit in paper form if attachments are required
- Paper claims are scanned and converted to electronic formats with 48 hours

- Claims must be submitted on original, red and white CMS1500 or CMS1450 (UB-04) claim forms with black, machine printed text.
- Attachments must be printed on 8.5" x 11" paper and must accompany a valid claim form.

Portal Users, upon login, are presented with the portal user page where they can:

- Upload 837 claims files
 - A file explorer dialog allows you to select the claim file
 - Once selected the file is saved to a secure drive
 - The saved file is immediately processed to confirm it is in a valid format and that the patient is an eligible member of one of the supported health plan products
 - Log files are generated to record the outcome of the validation process and made available for download by the portal user





- 837 files that are successfully uploaded are queued for in-loading to the claims processing system within 24 hours.

The Edifecs Compliance Online tool provides a testing platform which ensures HIPAA compliancy.

We would recommend that for initial compliancy testing you use this tool or some other HIPAA compliancy tool to validate your transactions before you attempt to send us files, to ensure that the information you are sending meets HIPAA compliancy guidelines.

- Download 835 remittance advice files
 - The most recent check run cycles are presented as a selection criterion
 - The 835 file is generated for the selected check run and made available for download
- Review and update user account contact information in their profile page
- Reset their password
